



Lysander-Canso Short Term and Floating Rate Fund was awarded the 2023 Fundata FundGrade A+[®] Award in the Canadian Short Term Fixed Income Category, out of 161 funds. The FundGrade start date was 1/31/2014 and FundGrade end date was 12/31/2023. Performance for the fund (Series A) for the period ended February 29, 2024 was 5.4% (1 year), 1.2% (3 years), 2.3% (5 years) and 1.9% (10 years).
