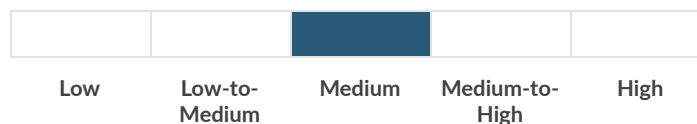
Invests in the equity securities of global companies with sustainable competitive advantages and durable growth prospects.

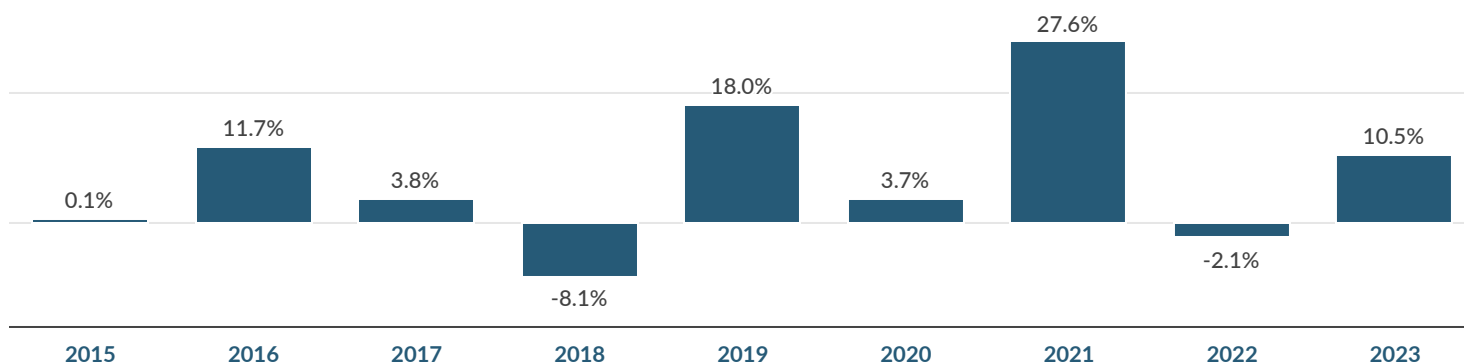
