

Lysander-Canso Short Term and Floating Rate Fund was awarded the 2023 Fundata FundGrade $A+^{\$}$ Award in the Canadian Short Term Fixed Income Category, out of 161 funds. The FundGrade start date was 1/31/2014 and FundGrade end date was 1/31/2023. Performance for the fund (Series A) for the period ended March 31, 2024 was 5.7% (1 year), 1.3% (3 years), 2.4% (5 years) and 2.0% (10 years).

The annual FundGrade A+® Awards are presented by Fundata Canada Inc. to recognize the "best of the best" among Canadian investment funds.
