

Lysander-Fulcra Corporate Securities Fund was awarded the 2023 Fundata FundGrade A+® Award in the High Yield Fixed Income Category, out of 161 funds. The FundGrade start date was 1/31/2017 and FundGrade end date was 12/31/2023. Performance for the fund (Series A) for the period ended March 31, 2024 was 7.5% (1 year), 3.7% (3 years), 5.1% (5 years) and 4.8% (since inception – December 30, 2016).

The annual FundGrade A+® Awards are presented by Fundata Canada Inc. to recognize the "best of the best" among Canadian investment funds. The FundGrade A+® calculation is supplemental to the monthly FundGrade ratings and is calculated at the end of each calendar year. The FundGrade rating system evaluates funds based on their risk-adjusted performance, measured by Sharpe Ratio, Sortino Ratio, and Information Ratio. The score for each ratio is calculated individually, covering all time periods from 2 to 10 years. The scores are then weighted equally in calculating a monthly FundGrade.
